SAP Guidelines

- Federal regulations require students to maintain Satisfactory Academic Progress (SAP) in three areas – GPA, hours earned, and maximum credit hours limit – to be eligible for financial aid.
- It is the student’s responsibility to stay informed on the SAP standards and to monitor his/her individual progress.
- Submission of an appeal is NOT an automatic approval for financial aid. Students will be notified of decision through email address provided above.
- Students who have reached his/her 600% Lifetime Eligibility for Pell Grant or maximum loan limit are NOT eligible to appeal.
- If such extenuating circumstances can be documented for the specific semester(s) when the said circumstances occurred, the student may submit this completed appeal form along with all required documentation for consideration. Northwest-Shoals Community College will consider the ability to complete the program within the maximum credit hours when considering an appeal request.
- All appeals are reviewed by the Appeals Committee and the decision is final.

What are Extenuating/Special Circumstances?

Situations considered extenuating circumstances are beyond a person’s control such as:

- Serious illness or injury to student that required extended recovery time.
- Death or serious illness of an immediate family member.
- Significant trauma in student’s life that impaired the student’s emotional and/or physical health.

Directions for Submission

- 2020-2021 FAFSA confirmation page
- A signed, dated, detailed letter of explanation. Please make sure to address the specific semesters where you experienced academic problems, changes of major, or withdrawals. Include what actions you took to make an effort to meet your responsibilities during the time of your extenuating circumstances and how your circumstances have improved. If appeal is for max credits, the letter should explain why you will not be able to graduate within the maximum credit hours allowed and how your circumstances have improved. If you are seeking a second degree, include information as to why you are changing your career path.
- Documentation that the event you described occurred. (Statement from your physician, medical bills, police report, obituary, etc.) **If your appeal is for maximum credits or a second degree, you will also provide a degree audit from the Student Success Center.**
- A completed and signed appeal application.
- NW-SCC unofficial transcript (which can be printed from self-service banner account).
- Appeal packets must be submitted to the Muscle Shoals Campus Student Financial Services Office only.

Satisfactory Academic Progress

Federal regulations require students to maintain Satisfactory Academic Progress (SAP) in three areas – GPA, hours earned, and maximum timeframe – to be eligible for financial aid. **It is the student's responsibility to read and understand all policies associated with financial aid funding.**

1. *Maximum Credit Hours:* Each student receiving financial assistance will be expected to complete his/her course of study within a period not to exceed 1.5 times the length of his/her program of study; e.g. a two-year program of study (4 semesters, 64 hours) must be completed within 3 years (6 semesters, 96 hours) of attendance.
2. *Qualitative Measures:* Each student will be expected to meet or to exceed the following GPA value when satisfactory academic progress is checked:
 - If the student has attempted 1-21 hours, they must maintain a 1.5 Financial Aid GPA.
 - If the student has attempted 22-32 hours, they must maintain a 1.75 Financial Aid GPA.
 - If the student has attempted 33 & above hours, they must maintain a 2.0 Financial Aid GPA.

**Please refer to section 4 Additional Regulations to see what is included in calculating financial aid GPA.*

3. *Quantitative Measure:* Each student will be expected to meet or to exceed the following completion rate when satisfactory academic progress is checked:
 - If the student has attempted 1-21 hours, they must have a 58% completion rate.
 - If the student has attempted 22-32 hours, they must have a 62% completion rate.
 - If the student has attempted 33 & above hours, they must have a 67% completion rate.

**Please refer to section 4 Additional Regulations to see what is included in calculating completion rate.*

4. *Additional Regulations:*

- Accepted transfer hours from all accredited colleges will be included in the completion rate calculation.
- All prior coursework at NW-SCC will be included in completion rate and GPA calculations.
- If a student does not meet any of the requirements listed the student will be given one warning semester in which he/she will be eligible to receive aid. There is no warning period for MAX timeframe and that situation cannot be improved.
- After the warning semester the student must have the required GPA and/or completion rate to continue to receive financial aid assistance or financial aid will be suspended.
- If financial aid funds are suspended the student may file an appeal based on any mitigating circumstances that caused the student to be unsuccessful in their coursework.
- Information as to the treatment of repeat, incompletes, withdrawals, transfer credit, bankrupted, forgiven, and transitional (remedial) classes is as follows:
 - Incompletes will be factored into the completion rate and maximum timeframe calculations.
 - Withdrawals will not be factored into the GPA calculation but will be included in the completion rate and maximum timeframe calculations.
 - Repeat classes will be factored into the GPA, completion rate, and maximum timeframe calculations. In addition, a student can only repeat a successfully-passed class using federal aid once.
 - Transfer credits from accredited colleges will not be factored into the GPA calculation but will be included in the completion rate and maximum timeframe calculations.
 - Bankrupted classes will be factored into the GPA, completion rate, and maximum timeframe calculation.
 - Forgiven classes will not be factored into the GPA but will be included in the completion rate and maximum timeframe calculations.
 - Transitional (remedial) classed will be factored into the GPA, completion rate, and maximum timeframe calculations.
 - Dropped courses during the add/drop period will not be factored into GPA, completion rate, or maximum timeframe calculations.
